Feature enhancements

Drawings - Revision numbers

In the drawing settings, you can select how revision numbers are set for uploaded drawings:

- Sequential:** If the drawing is the first revision in the drawing series, the revision number is automatically set to the drawing revision default from the field attribute settings. If the drawing is a subsequent revision, the revision number is incremented automatically based on the drawing marked as Current.
- Extract revision number from title block:** The application uses AI to identify the revision number in the title block.

Note:

- If the revision number is not detected, the Revision field remains empty, and you can enter the revision number.
- If the same revision number is detected for two drawings in the same upload, one drawing is published successfully with the revision number. The other drawing is a duplicate with the Approved status, and you can change its revision number.


Revision number setting for drawings

Workflow templates - Step completion time

In workflow templates, you can set the number of completion days for each step. When you apply the workflow template to a record, the completion days are used to calculate the step due date.

Note:

- Finish steps and steps with the Draft status don't have a completion time.
- For workflow templates that you created prior to this release, the completion time per step is calculated based on the previous workflow completion time. The completion time may not match the original time, so you can review and adjust the number of days as needed.

Resolved issues

- Project exports are generated successfully. (CN 000004570 / PS-64644)
- When a file is uploaded and attached to a PCO, the upload time is displayed correctly. (CN 000004610 / PS-64850)
- When a module is opened, errors are no longer displayed. (CN 000004621 / PS-64905)
